

My efforts are devoted to clinical care, innovative program building, teaching, mentoring and research. I have a special interest in the management of pain of surgical and trauma patients on chronic high dose opioids with a focus on improving the quality and safety of pain management in these challenging patients. I am well recognized among the national and international pain management community because of my innovative program building and knowledge transfer.

I am particularly proud of the Perioperative Personalized Pain Program (PPP), a novel clinical program; the first of its kind in the US that I founded in 2017 in response to the opioid epidemic. This program led to a \$1.8 million NIH/CDC RO1 grant award in 2019. I will elaborate on this program under clinical innovation.

with my clinical experience in acute pain medicine and the multidisciplinary perioperative pain program and my leadership skills I will be able to bring all subspecialties of pain together and create a unified voice through AAPM to encourage multidisciplinary, personalized pain care and to guide science, policy, and patient education to overcome the Opioid crisis.

4. Describe one transformational/defining experience in your professional life you have been involved with and what you learned from the experience.

In 2017, and in response to the opioid epidemic, I founded the Personalized Perioperative Pain Program PPP, recognizing that the perioperative period is a unique opportunity to develop well-coordinated care in pain management for surgical patients on chronic opioids and with substance use disorder. In collaboration with faculty from the Johns Hopkins Carey business school, we developed the business plan for the program. This clinic model, the first of its kind in the US, involves a multidisciplinary approach to address various aspects of pain management and opioid utilization. The PPP has helped to reduce opioid use among chronic opioid users during the perioperative period and up to 6 months after surgery. Currently in its 7th year, has borne witness to glimmers of hope amidst the current opioid epidemic. Every patient in the PPP represents a success story in weaning opioids even in the most stressful perioperative time. Our clinic effectively reduced opioid usage without negatively influencing patient-reported outcomes, such as physical pain score and health-related quality of life. Many patients with an amputated limb, recovered and successfully managed their phantom pain and weaned off opioids. Patients with opioid use disorder (OUD) connected to MAT (maintenance treatment program) follow a weaning protocol and managed their pain safely in this program. I learned to be passionate and do the right thing for my patients and have the strategy to build programs that could be exemplary to other institutions while managing a health care crisis.

Personal Background: I emigrated to the US with my husband, a successful surgical oncologist, more than 30 years ago. I am a mother of three successful young adults, two sons in surgical oncology fellowship and one daughter a dentist at Johns Hopkins. I strove throughout my career to manage a well-balanced life as a clinician and a mother. I advanced from one leadership position to another in medicine in the USA, while maintaining my ties to my country of origin, Egypt and my roots in the Coptic Orthodox Church. I always give my faith and my family priority and I am very passionate about giving my patients the best care I can give. I continue to maintain a high standard of teaching my trainees and to serve the American Academy of Pain medicine
