

1. The Academy has focused on Convene, Educate Providers, Research, and Access Advocacy. The Board of Directors leads our strategic planning and formation of annual strategic objectives. Based on the above plan, your professional experiences, and experiences with the Academy, what suggestions would you make to move the Academy forward? Please keep comments to 300 - 500 words.

As a practice owner in San Diego, I have noticed that many insurance payors dictate many of our treatment options and restrict patient access to evidence-based care. We are the experts, and in addition to striving for high-quality RCT data for our treatments and services, I believe providing cost analysis data may help to reduce the heavy restrictions implemented by many insurance payors. Cost analysis can include site of service (office, ASC, HOPD) and long term costs such as frequent ED visits, prolonged opiate dependence, work absenteism and need for further costly treatments and/or surgery. Cost analysis data aligns with convene, educate payors, research and access advocacy and hopefully can ensure pain physicians are central in advancing the science and practice of our treatments for our patients.

2. What is your professional vision for the future of Pain Medicine?

My professional vision for the future of pain medicine is to educate our physicians on the science, the practice and the business of what we do so that we can improve how we care for patients, and ensure we have long term job security and moral and ethical leadership in improving the care of our patients. My concerns is that the insurance and workers comp payor restrictions will continue to limit our progress in caring for patients, and limit patients access to evidence based technologies.

AAPM is the premiere pain society with a strong reputation and national influence. I believe AAPM is a key catalyst for pain physicians to come together and advance the field pain and ensure patients have access to high quality, evidenced-based treatments.

Independent practice ownership in San Diego. San Diego is an extremely competitive HMO insurance market and it was difficult to obtain contracts and develop a referral network. Understanding payor mix, site of service and cost-analysis allowed us to develop a strategic plan and practice-model that allowed us to secure competitive contracts and advanced innovative therapies such as PNS, in a market that was closed.
