

I was approached by Farshad Ahadian about this role. As a member of the AAPM Board of Directors, I have been active in grant writing and brainstorming about pursuing large grants that will advance pain research and educate providers, payors, policymakers, patients, and the public.

I have been actively involved in AAPM's journal, annual meetings, publications, and grant applications. Additionally, as an active member of multiple medical societies, I will continue to build bridges and encourage collaboration and synergy between AAPM and other relevant organizations.

My clinical care, ongoing research, and publications span the full spectrum of multidisciplinary care, from interventional pain procedures to pain psychology to pharmacotherapy and complementary and integrative medicine. This includes twice winning top abstract awards for research on pain psychology presented at AAPM 2020 Annual Meeting and research on cannabinoids for acute migraine presented at AAPM 2024 Annual Meeting.

2. What is your professional vision for the future of Pain Medicine?

Multidisciplinary pain care via the biopsychosocial model with novel interventional, psychological, rehabilitation, pharmacological, and CIM treatments advancing the field. Advocacy by and on behalf of clinicians to preserve the clinician-patient relationship and decrease barriers to safe, effective, patient-centric care.

I've enjoyed this year serving on the AAPM Board of Directors and as AAPM's representative to the Multisociety Pain Workgroup for its forthcoming Sacroiliac Joint Guidelines. AAPM's mission and future success is important to me and I look forward to continuing to serve the Academy.

He graciously accepted this idea. Through my involvement in AAPM I served on its journal's editorial board, spoke at its meetings, and published peer-reviewed articles.

4. Describe one transformational/defining experience in your professional life you have been involved with and what you learned from the experience.

During my first year as an assistant professor at UCSD I wrote and received a grant to conduct the first placebo-controlled RCT of cannabinoids for acute migraine. This has been a transformational/defining experience for me. The lessons I learned with regards to grant writing, clinical trial design and implementation, FDA and other regulatory body interactions, and more from serving as principal investigator on this study have taught me so much about the hard work that goes into performing rigorous clinical trials and just how rewarding research can be.
